# **A.T. Maintenance Reports**

Reporting: Bettye Fox Boone Date: 1/31/2024 Purpose: Prepare for and attend Roan Highlands VUM Facilitation Meeting Location: Home People: Bettye Fox Boone

**Summary:** I prepared comments on Step 7 of the Roan Highlands VUM (Visitor Use Management) and emailed them to Tara prior to the Facilitation meeting. I virtually attended the VUM Facilitation meeting.

Date: 2/1/2024

Purpose: Rehab trail and construct steps

**Location:** Section 10, Hampton trailhead to Dennis Cove Road, Laurel Fork Shelter **People:** Dean Baird, Van Hovey, Bill Murdoch, Joe Morris, Tim Stewart, Dan Firth, Carl Fritz, Tony Messina, Bob Peoples, Tom Sahlin, Dave Allen

**Summary:** The Thursday crew rehabbed the blue-blaze access and water trails adjacent to the Laurel Fork Shelter. Several stone steps were installed. An additional trip is required to finish the water access trail. Part of the crew removed a hazard tree on the north side of Koonford Bridge. Some rehab was done on the high-water bypass trail and additional opportunities exist for improvement. A large blowdown was removed by the USFS 1/2 mile north of the shelter on the A.T.



Reporting: Vic Hasler Date: 2/2/2024 Purpose: Cut back azaleas and rhododendron

Location: Section 20b, Temple Hill Gap to half mile south People: Vic Hasler

**Summary:** I adopted Section 20b three years ago, thus the primary purpose today was to again clear the woody growth above the trail. Jerry and Joe completed a walk-thru last week, a pair of slack-packers from out west, which verified five large blowdowns north of No Business Knob Shelter and snow on the trail at Spivey Gap. Since the blowdowns require chainsaw use, I am hoping the USFS crew will remove them before the thru-hiker bubble starts arriving in March. Back in 2021, I had demonstrated that 0.5 mile of lopping is a good day's work; thus that is what was performed. Granny Lewis forest road still could benefit from boom mowing on the uphill side. I observed several sets of deep ruts where a truck veered into the soft roadway shoulder to avoid the remains of blowdowns. I removed a couple of the problems to reduce further damage. I also retrieved many beer and soft drink cans from the forest road for recycle.

Reporting: Van Hovey Date: 2/2/2024 Purpose: Clear blowdown Location: Section 20a, Nolichucky River to Temple Hill Gap, 0.29 mile from Uncle Johnny's People: Van Hovey, Carrie Hovey Summary: We removed the reported blowdown.

Reporting: Jim McGuire Date: 2/3/2024 Purpose: General Trail Maintenance Location: Section 15c, Hughes Gap to Ash Gap People: Jim McGuire, Cindy McGuire Summary: We traveled to Hughes Gap to look for blowdowns and I found them! Cindy and I climbed up to Ash Gap from Hughes Gap. When we arrived, there was no where to park. Ten cars were parked at the trailhead. We met 2 SOBO day hikers. There were just a few tracks in the snow, so the crowd from the cars must have gone north. I cleared more than 20 small-to-medium blowdowns and cleared many branches from the trail. There were two trees too big for me to clear. I will probably need the chainsaw crew. I'll send pictures and location. It is not difficult to get around them. The snow was about 8 inches deep on top of Beartown Mountain. I checked the water source just north of Hughes Gap. There was no water coming out of the pipe, but I adjusted it and got a good stream.

Date: 2/3/2024

Purpose: JCHC club hike, that became maintenance

Location: Sections 16a and 16b, Iron Mtn Gap to Hughes Gap

**Summary:** We brought handsaws on our scheduled JCHC club hike, in case we found blowdowns to clear, and we were not disappointed. For section 16a, Iron Mtn gap to Greasy Creek Gap, we cleared 6 blowdowns in the 7-9" range, 17 that were 4-6", and dozens more that were smaller than 4". From Iron Mtn Gap 3.5 miles, a 26" tree had blowndown (see pics). Fortunately, it was rotted enough to saw and break through the middle to reopen the trail. It was a similar blowdown situation from Greasy Creek Gap to Hughes Gap. We removed a 13", 14 that were 4-6", and dozens smaller. In the 3.4 miles between Clyde Smith Shelter and Hughes Gap, we left 8 blowdowns for chainsawing. Jim Foster will go back as swamper, with Yong Li as sawyer, as soon possible. Much of the trail was covered with up to a foot of snow, which limited the clearing of water diversions.



Reporting: Steve Perri Date: 2/3/2024 Purpose: Clear blowdowns Location: Section 4a, US 421 to Double Springs People: Steve Perri, Steve Wilson

**Summary:** We walked in and out from US 421 after a report of multiple blowdowns. We cut out 16 blowdowns with a chainsaw and lopped briars and other branches. We encountered about 15 hikers. Among them were Craig Haire and Eric Middlemas from the Mid-Appalachian Trail Club. They too were doing some trail clearing. Southbound hikers reported no blowdown obstructions south of McQueens Gap, but more north of there for a few miles. We'll look for another time to go north from McQueens Gap. The water is flowing well this time of year at the spring. The waterbars north from US 421 will need to be cleared out in another trip.

Purpose: Clear reported blowdowns

Location: Section 19b, Curley Maple Gap Shelter to Nolichucky River

People: Van Hovey, Carrie Hovey, Breanna Trauffer, Bobby Trauffer

**Summary:** Objectives for the day were threefold: Remove reported blowdowns, cut back encroaching rhodies, and introduce our new maintainers Breanna and Bobby Trauffer to various aspects of trail maintenance. In summary, it was a longer and more productive day than anticipated. The expectation was for 3 blowdowns, however we encountered: 2 - 18", 1-16", 1-14", 1-12", 1 double consisting of a 6" and 10" hung up over the trail, and perhaps a half-dozen others of numerous sizes ranging from 4-6". We also inspected and and cleaned the shelter (in good condition) and cut back some sizable rhodies overhanging the trail. We met a few NOBOs slack-packing and a few day hikers. Breanna and Bobby were a big help and will be good additions to our trail maintenance community. The trail is clear as of this date. Cheers.

Purpose: Clear blowdowns and encroaching branches

Location: Section 18, From Indian Grave Gap, 5 miles North to Unaka Mountain Rd "hairpin"

**Summary:** After the last big wind storm, Pat went up by himself and cleared our A.T. section. It is passable now till we can get through the gate and do more extensive clearing.

\*\*Also, Monday, Feburary 19, the Old Timers hike was from Walnut Mtn Road to Bitter End (Section 12a). As we hiked, multiple people removed blowdowns. This short section is now clear.



Reporting: Dave Allen Date: 2/6/2024 Purpose: Scout section for needed work Location: Section 1, TN/VA state line to Backbone Rock Trail People: Dave Allen

**Summary:** I hiked up Backbone Rock Trail, through Section 1 to TN/VA line. My purpose was to scout out my new section for needed work. I removed a few small blowdowns, and found 5 large blowdowns needing chainsaw work: two with large step-overs, 2 completely blocking the trail, and one large overhanging, broken tree. Backbone Rock Trail also had about a dozen blowdowns needing removal. I scheduled a followup chainsaw visit with Tony Messina (2/14) and another followup trip on 2/18 to take care of Backbone Rock Trail (no chainsaw work needed).

Reporting: Van Hovey Date: 2/7/2024 Purpose: Clear reported blowdowns Location: Section 19a, Indian Grave Gap - Curley Maple Gap Shelter People: Van Hovey, Carrie Hovey

**Summary:** We received a report of 3 blowdowns on the middle third section SOBO from Indian Grave Gap. We drove 1/2 mile in on FS road and walked to mile 350.1. Along the way, we encountered and dispatched the 3 blowdowns, all step-overs, nothing larger than 10" in diameter. We met two NOBO section hikers. It was a nice day to be out.

Location: Section 10, Hampton trailhead to Dennis Cove Road, Laurel Fork Shelter People: Van Hovey, Dave Allen, Tony Messina, Joe Morris, Bob Peoples, Tom Sahlin Summary: The Thursday crew split into two teams. This group started the rehabilitation of the water trail at Laurel Fork Shelter. Two stone steps, 4 locust steps, and 126 feet of trail rehab were accomplished.

**Purpose:** Clear water diversions and check for blowdowns **Location:** Sections 4a and 4b, TN 91 to US 421


**Summary:** We cleaned water diversions from Berry Fields to Double Springs Shelter; then cleaned water diversions from Berry Fields to US 421 well enough to last several months. Tim is planning a 2nd Saturday "Hiking with Tools" to clean those some more. We cleared a number of small blowdowns. One major double blowdown remains within 0.3 mile of Double Springs Shelter. We cut a reasonable path around it, so there is no hurry. The shelter and water source looked good. A log book is needed. The trail

looked to be in good shape. Trail dug by Ed Speer close to the shelter made walking much easier. We rehabbed some rock and log water diversions. There is still some snow at the shelter.

Reporting: Jim Foster Date: 2/9/2024 Purpose: Cut blowdowns Location: Section 16a, Hughes Gap to Clyde Smith Shelter People: Yong Li, Jim Foster **Summary:** Yong cut over 20 blowdowns while I helped clean trail and assisted him. It was a terrible weather day, but we made it happen. The section between Hughes Gap and Clyde Smith is free of obstructions.

Reporting: Michael Watts Date: 2/9/2024 Purpose: Clear blowdowns Location: Section 13, South of US 19E People: Rick Lott, Mike Watts

**Summary:** A short distance south of US 19E, we cleared two large blowdowns (the top half of a hemlock tree and a locust) and two small blowdowns. We picked up trash at 19E. We met two early thru-hikers from Louisiana. They started their hike on December 27 (skipped the Smokies due to weather).



Date: 2/10/2024

**Purpose:** JCHC club hike, but became maintenance

Location: Sections 20a, b, and c; Nolichucky River to Spivey Gap

People: Yong Li, Denny Samuel, Josh Banks, Ed Brading, Jeff Miller, Joy Zabel, Joel Zabel

**Summary:** Johnson City Hiking Club hiked from the Nolichucky River to Spivey Gap. Based on many blowdowns on hikes in the past weeks, we brought the Katanaboy saw and personal handsaws. The section from the Nolichucky to Temple Hill Gap was well maintained with only one 7" blowdown, that we removed. From Temple Hill Gap to No Business Knob Shelter, we saw evidence of recent clearing of blowdowns with fresh sawdust, but still found many new ones. We removed many under 6" diameter and several more up to 10". The biggest was a tree with multiple branches requiring cuts of 12", (2)10", 8", about 1/2 mile north of the shelter. South from the shelter, we removed most everything under 10", but ran into some big stuff and left a few as rain picked up on the way to Spivey. The ones that we left that are best handled by a chainsaw are listed, with the distance (miles) north from Spivey Gap and the largest diameter cut needed (though some require multiple cuts): (0.15) 10", (0.7) 12", (3.6) 18" tricky dead hemlock? (see pics), and (4.7 or 0.2 from NBK shelter) 14".

Purpose: Chainsaw work to remove blowdowns

Location: Section 1, TN/VA state line to Backbone Rock Trail and Backbone Rock Trail

People: Dave Allen, Tony Messina

**Summary:** We hiked up Backbone Rock Trail to approx 0.2 miles to TN/VA line to remove large blowdowns requiring chainsaw work. We removed a total of 12 blowdowns, 6 requiring a chainsaw, on A.T., and an additional 2 large blowdowns on Backbone Rock. The remaining blowdowns on Backbone Rock were left, due to a long day, for a scheduled follow up on 2/18.

Date: 2/14/2024

Purpose: Check trail conditions

Location: Section 9b, Pond Flats to Hampton trailhead
